SECOND FINAL BUDGET HEARING
MINUTES
OCTOBER 29, 2012**

1. PLEDGE OF ALLEGIANCE

Mayor Eisinger opened the Meeting at 6:00 p.m. and led the assembly in the Pledge of Allegiance.

2. ROLL CALL

Present were Commissioners Mallozzi, Sims, Curran, Green and Mayor Eisinger.

4. PUBLIC HEARINGS

Fiscal Year 2012/2013 Budget and Taxes

A. Second Final Public Hearing on Adoption of Fiscal Year 2012/2013 Millage Rate – Ord. No. 12-9-1

City Atty. Gabriel explained that this item provides for a final millage rate of 5.6866 mils, which is 15.04% above the rollback rate of 4.9430 mils, and also provides for a voter-approved voted debt service millage rate of 0.1906 mils; and read, "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING THE FINAL LEVY OF AD VALOREM TAXES FOR COOPER CITY FOR THE FISCAL YEAR 2012/2013; AND PROVIDING FOR AN EFFECTIVE DATE," by title only.

MOTION: To approve the Ordinance adopting the Millage Levy for Fiscal Year 2012/2013.

Moved by Commissioner Curran. Seconded by Commissioner Green. Motion passed 4-1 with Commissioner Sims dissenting.

B. Second Final Public Hearing on Adoption of Fiscal Year 2012/2013 Budget – Ord. No. 12-9-2

Atty. Gabriel read, "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, OFFICIALLY ADOPTING AND APPROVING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2012/2013 AND APPROPRIATING THE FUNDS REQUIRED FOR THE OPERATION OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE," by title only.

MOTION: To approve the Ordinance adopting and approving the Annual Budget for Fiscal Year 2012/2013 and appropriating the funds required for the operation of the City.

Moved by Commissioner Green. Seconded by Commissioner Curran. Motion passed 4-1 with Commissioner Sims dissenting.
