Discussion ensued with the Commission expressing grave concerns over some Broward County Commissioners' statements regarding the existing contract between Cooper City and the Broward Sheriff's Office for Law Enforcement and Fire Rescue Services.

Commissioner Curran requested that a review of the P&Z Advisory Board minutes be placed on a future agenda with consideration being given to the provision of verbatim minutes.

14. OPEN PUBLIC MEETING

Pete D'Aversa, 5712 SW 118th Avenue, spoke regarding veterans' health and welfare and asked the Commission to address Congresswoman Debbie Wasserman Schultz asking her to honor her previous commitment to veterans' affairs.

Walt Jolliff, 11095 Bismarck Place, opined regarding the BSO contract and the County Commission's public statements regarding Cooper City's funding.

12. FIRE CHIEF'S REPORT

Chief Caruso announced that he is looking forward to participating in the Touch-A-Truck event and reminded residents that June 1st begins Hurricane Season, and standard precautions should be taken.

13. CITY MANAGER REPORT

City Manager Loucks reported that a computer glitch caused a discrepancy in generating the newly formatted utility bills, resulting in the necessity for the City to process a number of bills in their previous format to correct the error.

15. COMMISSIONERS' CONCERNS/REPORTS

Commissioner Green expressed his gratitude to the US Military personnel and particularly veterans who have given their lives in service. He paid homage to his brother, Sgt. Michael Curry. He extended his condolences to the family of Ray Pecoraro, owner of Ray's Pizza, who passed away this past weekend.

Commissioner Curran addressed the need for veterans' benefits and healthcare to be a priority and expressed support for Mr. D' Aversa's request. He expressed his condolences to the family of the Cooper City High School senior who lost her life this past weekend to a brain aneurism.

Commissioner Sims expressed his support for Mr. D' Aversa's request and his support for veterans' rights and benefits. He expressed his condolences to the families of all those who have lost their lives in service to our country.

Commissioner Mallozzi expressed her support to Mr. D'Aversa and to servicemen and women past and present.

Mayor Ross expressed his support for Mr. D' Aversa's request and advised that he will write the letter to Congresswoman Wasserman Schultz. He expressed his condolences to Commissioner Green for the loss of his brother.
