Wolpin read, "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CODE OF ORDINANCES BY CREATING SECTION 2-24 "MAYOR AND COMMISSIONERS' SALARIES" OF CHAPTER 2 "ADMINISTRATION"; IN ORDER TO THE MONTHLY SALARY OF THE **MAYOR** COMMISSIONERS AS ALLOWED BY CITY CHARTER SECTION 3.06; **PROVIDING FOR** REPEALER; **PROVIDING FOR** SEVERABILITY; PROVIDING FOR INCLUSION IN CODE; AND **PROVIDING FOR AN EFFECTIVE DATE,"** by title.

MOTION: To approve the Ordinance No. P14-13.

Moved by Commissioner Green. Seconded by Commissioner Curran.

MOTION: To set the Commission salaries at \$18,000.00 each with an additional 20% increase to the Mayor's salary, bringing it to \$21,600.00.

Moved by Commissioner Green. Seconded by Commissioner Mallozzi. Motion failed 4-1 with Commissioner Green voting yes.

MOTION: To raise the Commission salaries by \$500.00 per month and an additional 20% increase to the Mayor's salary, for \$600.00 per month.

Moved by Commissioner Curran. Seconded by Commissioner Mallozzi. Motion passed 3-2 with Commissioner Sims and Mayor Ross dissenting.

City Atty. Wolpin read, "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CODE OF ORDINANCES BY AMENDING CHAPTER 9, "BUSINESS TAXES", ARTICLE "BUSINESS OCCUPATIONAL SECTION 9-7, **USES** RESIDENCES", IN ORDER TO AMEND THE CITY'S BUSINESS TAX REGULATIONS, REGARDING THE PERMITTING AND REVOCATION **AMENDING** SECTION 9-14 "DELINOUENCY" **AUTHORIZING ENFORCEMENT ACTION PURSUANT TO ARTICLE** VI "CODE ENFORCEMENT" OF CHAPTER 13 "PUBLIC SAFETY" OF THE CITY CODE FOR ANY VIOLATION OF SECTION 9-7; REPEALING ARTICLE III, SECTION 9-28, "OUTDOOR SALES" IN ITS ENTIRETY; ESTABLISHING A NEW ARTICLE III, CONSISTING OF "SPECIAL **EVENTS**; **REGULATIONS**; SECTION 9-28, ENFORCEMENT" AND SECTION 9-29, **"OUTDOOR** REGULATIONS; ENFORCEMENT", CONCERNING SPECIAL EVENTS AND OUTDOOR SALES; AUTHORIZING ENFORCEMENT ACTION PURSUANT TO ARTICLE VI "CODE ENFORCEMENT" OF CHAPTER 13 "PUBLIC SAFETY" OF THE CITY CODE FOR ANY VIOLATION OF ARTICLE III OF CHAPTER 9; PROVIDING FOR REPEALER; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN **EFFECTIVE DATE,"** by title.

Moved by Commissioner Green. Seconded by Curran. Motion passed 3-1 with Commissioner Sims dissenting and Commissioner Mallozzi absent.

8. ORDINANCE FOR FIRST READING AND PUBLIC HEARING

Amending Chapter 23 of the Code of Ordinances – Ord. No. 14-15 **Mayor Ross opened the Public Hearing.**

City Atty. Wolpin read, "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AFFIRMING THAT THE CITY WILL APPROVE ONLY USES CONSISTENT WITH STATE AND FEDERAL LAW; AMENDING CHAPTER 23 "ZONING DISTRICTS" TO CLARIFY THAT USES AND ACTIVITIES PROHIBITED UNDER STATE OR FEDERAL LAW (INCLUDING, BUT NOT LIMITED TO, STATE OR FEDERAL LAWS PROHIBITING MARIJUANA RELATED BUSINESSES OR ACTIVITIES) ARE PROHIBITED IN THE CITY; PROVIDING FOR A MORATORIUM; PROVIDING FOR MORATORIUM RELIEF; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR AN EFFECTIVE DATE," by title.

Motion: To approve the Ordinance No. P14-15.

Moved by Commissioner Green. Seconded by Commissioner Curran. All aye on roll call vote. Motion passed.

9. DISCUSSION AND/OR ACTION

13. OPEN PUBLIC MEETING

John Orlando, 11532 SW 55th Court, extended his appreciation to Commissioner Curran for making Code Enforcement a priority.

Beth Kroll, 11553 SW 57th Street, thanked Commissioner Curran for seeing to it that codes are enforced and opined that removing code or restrictions would be a detriment to the City.

Brenda Kezar, 4979 SW 90th Avenue, spoke in reference to Commission and candidate conduct with reference to the upcoming election and addressed Commissioner Mallozzi directly.

David Nall, 3620 NW 89th Way, commended the Commission regarding the salary increase and addressed Commissioner Green directly.

Pete D'Aversa, $5712~SW~118^{th}$ Avenue, spoke regarding the Commission salaries, suggested that it should have been a campaign issue and addressed the budget process.

Douglas McKay, SW Ranches Councilman, commended the Commission regarding their passing of the ordinance to increase Commission salaries.

Frederick Walker, Cooper's Point, congratulated the Commission for increasing the Commission salaries.

Stephen Bass, 5303 SW 118th Avenue, addressed the Commission regarding a code violation in his neighborhood and suggested the City collect higher utilities deposits from residents with lower credit scores.

9. DISCUSSION AND/OR ACTION_continued

A. Discussion regarding the Code of Ordinances which govern roof violations – **Commissioner Mallozzi**

Direction was given to the City Manager to conduct a study regarding methods used for shingle roof maintenance that will not cause damage to roofs.

MOTION: To extend the Commission Meeting passed the 9:30 PM limit. Moved by Commissioner Curran. Seconded by Commissioner Green. All aye on roll call vote. Motion passed.

B. Discussion regarding 53rd Street – **Commissioner Sims**

City Manager Loucks and Public Works Director Jim Bowman outlined the details of the parameters of the Broward County traffic studies in the areas surrounding SW 53rd Street.

C. Discussion and direction for Code Enforcement Case #04649, Respondents John B. Sims III and Janet Zanakis – **Administration**

City Manager Loucks presented his recommendation that an independent magistrate and an independent prosecutor be hired by Commission approval to hear this code violation case to avoid any potential perceived conflicts of interest.

MOTION: To direct the City Manager to bring recommendations for an independent Special Magistrate and an independent prosecutor to be voted on by the Commission to hear and try this case.

Moved by Commissioner Green. Seconded by Commissioner Mallozzi. Motion passed 4-1 with Commissioner Sims dissenting.

10. POLICE CHIEF'S REPORT

Lieutenant Montgomery reported that glow sticks and wrist bands will be passed out by deputies to the children for trick-or-treating, current crime rate in Cooper City is 21% lower than the first six months of last year and arrests were made and property recovered in relation to three burglaries from the Cooper City parking facilities.

11. FIRE CHIEF'S REPORT

Chief Caruso reported the following:

- The Broward County Commission voted to approve a Certificate of Conformance for transporting patients from ALS facilities to hospitals.
- October is Fire Prevention Month and life-safety educators, including Search and Rescue dog, Dig and his handler Nicole Knot, are visiting schools to teach about the importance of smoke detectors in homes.
- On October 23rd, an anti-texting and driving program will be conducted at Cooper City High School.

12. CITY MANAGER REPORT

City Manager Loucks noted the number of Financial Matters on the Agenda, advised that there would be more of these type of items on upcoming agendas and explained the code and magistrate process.

14. COMMISSIONERS' CONCERNS/REPORTS

Commissioner Green asked Lieutenant Montgomery for additional patrols in the area of SW 90^{th} during the closing time of the local bar as some residents have expressed safety concerns and responded to remarks made to him by David Nall.

Commissioner Curran commended the Fire and Police Departments for their outstanding efforts when his wife was involved in a car accident and addressed code enforcement standards throughout the City.

Commissioner Sims thanked Police and Fire, extended get-well wishes to Commissioner Curran's wife and expressed his opinion regarding Commission pay raises and why he voted against them.

Commissioner Mallozzi addressed Fire and Police, responded to earlier accusations made by a resident and reminded residents of the upcoming City events.

Mayor Ross reminded everyone that there is approximately $2\frac{1}{2}$ weeks until the election and asked them to vote.
