WHO: Ladies competing for the Miss COOPER CITY USA® title must be at least 18 and under 27 by January 1, 2018 born between 1991 and 1999 and ladies competing for Miss Cooper City Teen USA must be at least 14 and under 19 by January 1, 2017 born between 1999 and 2003. Women born in 1999 can compete in either division.

WHEN: THE PAGEANT WILL TAKE PLACE THURSDAY March 9th WITH THE DELEGATES MEETING AT 4:00 P.M. AT THE COOPER CITY HIGH SCHOOL AUDITORIUM WITH THE SHOW BEGINNING PROMPTLY AT 7:00 P.M.
